Abstract: Spreckels financial records primarily concern the financial activities and investments of Adolph and John Spreckels. The bulk of the collection spans the years from 1880 to 1925, documenting the financial transactions of several joint ventures statewide. Includes ledgers, journals, cash books and other materials relating to the Coronado Beach Co., Hotel Del Coronado, California Sugar Refinery, and other Spreckles ventures. Includes papers on the yacht Venetia, which served in the U.S. Navy in World War I. With these are 2 albums of newsclippings from 1934 to 1944.

Scope and Content

Spreckels Financial Records primarily concern the financial activities and investments of Adolph B. Spreckels and John D. Spreckels, sons of Claus Spreckels, founder of the California Sugar Refinery. The bulk of the collection spans the years from 1880 to 1925, and consists of the ledgers and journals, documenting the financial transactions of several joint ventures statewide. Also included are 2 albums of newspaper clippings from 1934 to 1944.
