Biographical note

Born November 13, 1937 in Buffalo, New York, George Frederick William Young is an American-Canadian historian and Emeritus Professor of History at Saint Mary's University in Nova Scotia. Young received his bachelor's degree from Harvard University, his master's degree from the University of Freiburg in Germany, and his Ph.D. in 1969 from the University of Chicago. He spent some time in Chile from 1964 to 1965 studying as a Fulbright Scholar. Young then began his career in academia at the State University of New York at Buffalo as a lecturer in history in 1965. After achieving his doctoral degree, he became an assistant professor of history at Saint Mary's University, where he would continue the rest of his career. Young is also an amateur musician and was, for a short time, CEO of a small utilities company in Northern Pennsylvania. He married in 1963 and has three children.

Scope and Contents note

The collection consists primarily of photocopies of printed matter (articles and book excerpts) and reproductions of archival materials from other repositories including, among others, the U.S. National Archives, the British Museum, the Weltwirtschafts-Archiv in Hamburg, and the Institut für Seeverkehr in Kiel, relating to German business investment in Latin America before World War II, especially in the period before World War I. Some of the articles Young wrote using these research materials are included, as are his notes.

Also included are seven microfilm reels containing selected documents relating to German banking and investment, dating from 1845-1938. These documents were used as research material for journal articles by Young.
